APPLICATION FOR A PERMIT

To appropriate the Ground Waters of the State of Oregon

I, Harry Pon (Name of applicant) of P. O. Box 1191, Burns (Postoffice Address), county of Harney state of Oregon, do hereby make application for a permit to appropriate the following described ground waters of the state of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. Give name of nearest stream to which the well, tunnel or other source of water development is situated East Branch Foley Slough (Name of stream)

2. The amount of water which the applicant intends to apply to beneficial use is 5.18 cubic feet per second or gallons per minute.

3. The use to which the water is to be applied is irrigation & supplemental irrigation

4. The well or other source is located ft. and ft. from the corner of #5 N33° W 1400 ft. from the SE corner of Section 28 (Section or subdivision) #14 N66° E 1270 ft. from the SW corner of Section 33 (If preferable, give distance and bearing to section corner)

being within the #5 SE 1/4 SE 1/4 #14 SW 1/4 SW 1/4 of Sec. 28 33 Twp. 22 S R. 31 E W. M., in the county of Harney

5. The (Canal or pipe line) to be miles in length, terminating in the (Smallest legal subdivision) of Sec. Twp. R. W. M., the proposed location being shown throughout on the accompanying map.

6. The name of the well or other works is Wells #5 and #14

DESCRIPTION OF WORKS

7. If the flow to be utilized is artesian, the works to be used for the control and conservation of the supply when not in use must be described.

8. The development will consist of two wells having a diameter of 12 inches and an estimated depth of #5-500 #14-85 feet. It is estimated that #5-not known #14-12 feet of the well will require steel casing. Depth to water table is estimated #5-not known #14-12 feet. #14 Test 900 g.p.m. with 43 ft. drawdown

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 5.18 cubic feet per second measured at the point of diversion from the well or source of appropriation, or its equivalent in case of rotation with other water users, from wells Nos. 5 and 14

The use to which this water is to be applied is supplemental irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed acre feet per acre for each acre irrigated during the irrigation season of each year; the right allowed hereunder for the appropriation of water for lands having a valid prior right shall be limited to the amount necessary to make up any deficiency in water available to said lands under said prior right and the amount allowed herein, together with the amount secured under any other right existing for said lands, shall be limited by the duty of water as fixed herein,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be cased as necessary in accordance with good practice and if the flow is artesian the works shall include proper capping and control valve to prevent the waste of ground water.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.

The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

The priority date of this permit is April 5, 1961

Actual construction work shall begin on or before May 17, 1961 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1961

Complete application of the water to the proposed use shall be made on or before October 1, 1961
