THIS PERMIT IS HEREBY ISSUED TO

CITY OF CHILOQUIN 122 S. 2ND STREET CHILOQUIN, OREGON 97624

This superseding permit is issued to describe an amendment for an additional point of appropriation proposed under Permit Amendment Application T-12955 and approved by Special Order Vol. 112, Page 26, entered January 6, 2019, and to describe an extension of time for complete application of water approved July 29, 2016, and a Water Management and Conservation Plan approved by Special Order Vol. 105, Page 917 on September 29, 2017. This permit supersedes Permit G-11503.

The specific limits and conditions of the use are listed below.

SOURCE OF WATER: WELLS 1, 2, AND 3 IN THE WILLIAMSON RIVER BASIN

PURPOSE OR USE: MUNICIPAL USE

MAXIMUM RATE: 1350 GALLONS PER MINUTE (GPM), BEING 650 GPM FROM WELL 1, 700 GPM FROM WELL 2, OR ITS EQUIVALENT IN CASE OF ROTATION, MEASURED AT THE WELLS

DATE OF PRIORITY: APRIL 1, 1991

Permit Amendment T-12955 Conditions:

The combined quantity of water diverted at the new point of appropriation (Well 3), together with that diverted at the old points of appropriation (Wells 1 and 2), shall not exceed the quantity of water lawfully available at the original points of appropriation (Wells 1 and 2).

Water use measurement conditions:

- a. Before water use may begin under this order, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, at each new point of appropriation.
- b. The water user shall maintain the meters or measuring devices in good working order.
- c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

Water shall be acquired from the same aquifer as the original points of appropriation.

The proposed Well 3 shall be constructed to produce solely from the deeper volcanic units, which would require continuous case and seal to approximately 400-500 feet below land surface.

Water Management and Conservation Plan Conditions:

Duration of Plan Approval:

1. The City of Chiloquin's Water Management and Conservation Plan is approved and shall remain in effect until **September 29, 2027**, unless this approval is rescinded pursuant to OAR 690-086-0920.

Development Limitation:

2. The limitation of the diversion of water under Permit G-11503 established in the Final Order approving an Extension of Time for Permit G-11503 (issued on September 15, 2009) remains unchanged. Subject to other limitations or conditions of the permit, therefore, the City of Chiloquin

remains authorized to divert only up to 2.29 cfs / 1029 GPM (out of the total permitted 3.01 cfs / 1350 GPM) of water under Permit G-11503.

Plan Update Schedule:

The City of Chiloquin shall submit an updated plan meeting the requirements of OAR Chapter 690, 3. Division 086 within 10 years and no later than March 29, 2027.

Progress Report Schedule:

The City of Chiloquin shall submit a progress report containing the information required under OAR 4. 690-086-0120(4) by September 29, 2022.

Other Requirements for Plan Submittal:

5. The deadline established herein for the submittal of an updated Water Management and Conservation Plan (consistent with OAR Chapter 690, Division 086) shall not relieve the City of Chiloquin from any existing or future requirement(s) for submittal of a Water Management and Conservation Plan at an earlier date as established through other final orders of the Department.

Original Permit Conditions:

Within one year from the date the Water Resources Commission adopts rules describing the schedules, standards and procedures for water conservation management plans by water suppliers, the city shall submit a plan which is consistent with said rules.

Within one year of permit issuance, the city-shall-prepare a plan/timetable for the Water Resources Commission which shall indicate the steps which the City intends to pursue to obtain a long-term water supply.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a usable access port, and may also include an air line and pressure gauge adequate to determine water level elevation in the well at all times. When required by the department, the permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

Prior to receiving a certificate of water right, the permit holder shall submit the results of a pump test meeting the Department's standards, to the Water Resources Department. The Director may require water level or pump test results every ten years thereafter.

The original permit was issued May 26, 1992. Complete application of the water to the use was to be made on or before October 1, 1995. By Extension of Time Final Order dated September 15, 2009, the deadline for complete application of water to use was extended to October 1, 2049. Within one year after complete application of water to the proposed use, the permittee shall submit a claim of beneficial use, which includes a map and report, prepared by a Certified Water Rights Examiner (CWRE).

Failure to comply with any of the provisions of this permit may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the permit.

This permit is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water shall be limited when it interferes with any prior surface or ground water rights.
