This superseding permit is issued to describe an amendment for a change in point of appropriation and additional points of appropriation proposed under Permit Amendment Application T-13733 and approved by Special Order Vol. 129, Page 1/20, entered April 6, 2024, and extensions of time approved May 1, 1984, March 8, 1989, February 9, 1994, and December 18 2020. This permit supersedes Permit G-9513.

This is to certify that I have examined Application G-9938 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to City of Donald, PO Box 388, Donald, Oregon 97020, Phone 678-3543, for the use of the waters of five wells, for the purpose of municipal use; that the priority of the right dates from September 16, 1980 and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.78 cubic foot per second measured at the point of diversion from the wells, or its equivalent in case of rotation with other water users.

Permit Amendment T-13733 Conditions:

The quantity of water diverted at the new points of appropriation (Well 1) shall not exceed the quantity of water lawfully available at the original points of appropriation (Well 1).

The combined quantity of water diverted at the new additional points of appropriation (City Hall Well, Community Center Well, and Oak Street East Well), together with that diverted at the original points of appropriation (Well 1 and Well 2), shall not exceed the quantity of water lawfully available at the original points of appropriation (Well 1 and Well 2).

The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Water shall be acquired from the same aquifer as the original points of appropriation.

Original Permit Conditions:

The wells shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in each well at all times.

The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

The original permit was issued February 8, 1982. Actual construction work was to begin on or before October 1, 1983 and complete application of water to the proposed use was to be made on or before October 1, 1984. By Extension of Time Final order dated December 18, 2020, the deadline for completing construction and for complete application of water to use was extended to October 1, 2030.
