APPLICATION FOR A PERMIT

To Appropriate the Ground Waters of the State of Oregon

I, Keith G. Johnson, of 910 Cascade Highway NE, Salem, Oregon, county of Marion, state of Oregon, do hereby make application for a permit to appropriate the following described ground waters of the state of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. Give name of nearest stream to which the well, tunnel or other source of water development is situated Un-named tributary of Beaver Cr.

2. The amount of water which the applicant intends to apply to beneficial use is 0.55 cubic feet per second or gallons per minute.

3. The use to which the water is to be applied is Irrigation

Well # - 1 Well # 2-4. The well or other source is located 8 ch. N and 11 ch. E from the SW corner of Section 27 T. 7 S., R. 1 W., W.M.

both being being within the SW 1/4 SW 1/4 of Sec. 27, Twp. 7 S., R. 1 W., W. M., in the county of Marion

8. The development will consist of two wells - one well having a diameter of 10 inches and an estimated depth of 210 feet. It is estimated that 28 feet of the well will require 10 inch Steel casing. Depth to water table is estimated 70 feet. The other well is a shallow well dug 100 feet x 200 feet x 10 deep

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.545 cubic feet per second measured at the point of diversion from the well or source of appropriation, or its equivalent in case of rotation with other water users, from two wells

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/80 of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be cased as necessary in accordance with good practice and if the flow is artesian the works shall include proper capping and control valve to prevent the waste of ground water.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.

The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

The priority date of this permit is April 14, 1964

Actual construction work shall begin on or before June 15, 1965 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1965

Complete application of the water to the proposed use shall be made on or before October 1, 1966
