APPLICATION FOR A PERMIT

To appropriate the Ground Waters of the State of Oregon

I, Webber and Elida Doughton (Name of applicant)

of Rt. 1, Box 326, Albany (Postoffice Address), county of Linn

state of Oregon, do hereby make application for a permit to appropriate the following described ground waters of the state of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. Give name of nearest stream to which the well, tunnel or other source of water development is situated Mill Creek (Name of stream)

tributary of South Santiam River

2. The amount of water which the applicant intends to apply to beneficial use is 600 cubic feet per second or 600 gallons per minute.

3. The use to which the water is to be applied is Irrigation

4. The well or other source is located South 75° West 21.5 chains ft. and ft. from the NE corner of Section 16, Township 11 South, Range 2 West. (N. or S.) (E. or W.) (Section or subdivision)

(If preferable, give distance and bearing to section corner)

being within the NW 1/4 of NE 1/4 of Sec. 16, Twp. 11 S, R. 2 W, W. M., in the county of Linn

5. The main pipe line to be 1250 feet miles (Canal or pipe line) in length, terminating in the SW 1/4 of SE 1/4 of Sec. 9, Twp. 11 S, NW 1/4 of NE 1/4 of Sec. 16, R. 2 W, W. M., the proposed location being shown throughout on the accompanying map.

6. The name of the well or other works is Doughton No. 1

DESCRIPTION OF WORKS

7. If the flow to be utilized is artesian, the works to be used for the control and conservation of the supply when not in use must be described.

8. The development will consist of one pump well (Give number of wells, tunnels, etc.) having a diameter of 12 inches and an estimated depth of 35 feet. It is estimated that 35 feet of the well will require steel casing. Depth to water table is estimated 8 (Feet)

9. (a) Give dimensions at each point of canal where materially changed in size, stating miles from headgate. At headgate: width on top (at water line) feet; width on bottom feet; depth of water feet; grade feet fall per one thousand feet.

(c) Length of pipe, 1250 ft.; size at intake, 5 in.; in size at 600 ft. from intake 4 in.; size at place of use 3 in.; difference in elevation between intake and place of use, + 2.5 ft. Is grade uniform? yes Estimated capacity, 1.50 sec. ft.

10. If pumps are to be used, give size and type 3" Gould Centrifugal

Give horsepower and type of motor or engine to be used 20 H. P. Electric

11. If the location of the well, tunnel, or other development work is less than one-fourth mile from a natural stream or stream channel, give the distance to the nearest point on each of such channels and the difference in elevation between the stream bed and the ground surface at the source of development



PERMIT

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.12 cubic feet per second measured at the point of diversion from the well or source of appropriation, or its equivalent in case of rotation with other water users, from Doughton Well.

No. 1

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be cased as necessary in accordance with good practice and if the flow is artesian the works shall include proper capping and control valve to prevent the waste of ground water.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.

The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

The priority date of this permit is December 16, 1965

Actual construction work shall begin on or before November 9, 1967 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1968

Complete application of the water to the proposed use shall be made on or before October 1, 1969
