APPLICATION FOR A PERMIT

To appropriate the Ground Waters of the State of Oregon

I, Ammon Bros Inc (Name of applicant) of Box 57 Jefferson (Postoffice Address), county of Marion, state of Ore, do hereby make application for a permit to appropriate the following described ground waters of the state of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. Give name of nearest stream to which the well, tunnel or other source of water development is situated Okegus Creek (Name of stream) tributary of Cuddy River

2. The amount of water which the applicant intends to apply to beneficial use is 800 cubic feet per second or 800 gallons per minute.

3. The use to which the water is to be applied is (Irrigation) Supplemental

4. The well or other source is located 65.0 ft. N (N. or S.) and 31.0 ft. W (E. or W.) from the corner of S E Corner Section 14 T 6 S R 1 W W M (Section or subdivision)

being within the SE 1/4 SE 1/4 of Sec. 14, Twp. 6 S, R. 1 W, W. M., in the county of Marion

5. The pipe line (Canal or pipe line) to be 4000 ft 8" trench miles in length, terminating in the SE 1/4 (Smallest legal subdivision) of Sec. 14, Twp. 6 S, R. 1 W, W. M., the proposed location being shown throughout on the accompanying map.

6. The name of the well or other works is Mt Angel Parish well no 1

DESCRIPTION OF WORKS

8. The development will consist of one (Give number of wells, tunnels, etc.) having a diameter of 12 inches and an estimated depth of 420 feet. It is estimated that 760 feet of the well will require 12" steel (Kind) casing. Depth to water table is estimated 40 (Feet)

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.78 cubic feet per second measured at the point of diversion from the well or source of appropriation, or its equivalent in case of rotation with other water users, from a well

The use to which this water is to be applied is supplemental irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be cased as necessary in accordance with good practice and if the flow is artesian the works shall include proper capping and control valve to prevent the waste of ground water.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.

The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

The priority date of this permit is January 22, 1968

Actual construction work shall begin on or before October 23, 1969 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1970

Complete application of the water to the proposed use shall be made on or before October 1, 1971
