This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.925 cubic feet per second measured at the point of diversion from the well source of appropriation, or its equivalent in case of rotation with other water users, from Wayne Howes Wells No. 1 and No. 2

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/20th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein,

The well shall be cased as necessary in accordance with good practice and if the flow is artesian the works shall include proper casing and control valve to prevent the waste of ground water.

The works constructed shall include an air line and pressure gauge and an access port for measuring line, adequate to determine water level elevation of the well at all times.

and shall be subject to such reasonable rotation system as may be ordered by the proper state officers

The well shall be so cased as to prevent the loss of underground water.

The priority date of this permit is August 11, 1955

Actual construction work shall begin on or before November 21, 1955 and shall

be prosecuted with reasonable diligence and be completed on or before October 1, 1956

Water to be used for the water to the proposed use shall be made on or before October 1, 1956
