make application for a permit to appropriate the following described ground waters of the State of Oregon:

1. The development will consist of one well. (Give number of wells, tile lines, infiltration galleries, etc.)

having a diameter of 6" and an estimated depth of 100 feet.

2. The well or other source is to be located 1100 ft. N. and 900 ft. E. (N. or S.) (E. or W.)

from the NW corner of Section 15 (Public Land Survey Corner)

(If there is more than one well, each must be described)

being within the SW 1/4 of the NW 1/4 of Sec. 15 Tp. 37 S. R. 1 E., W. M., in the county of Jackson.

3. Location of area to be irrigated, or place of use if use other than irrigation.

6. The amount of water which the applicant intends to apply to beneficial use is 0.20 cubic feet per second or gallons per minute.

7. The use to which the water is to be applied is irrigation and supplemental irrigat

9. If the location of the well, or other development work is less than one-fourth mile from a natural stream channel, give the distance to the channel and the difference in elevation between the stream bed and the ground surface at the source of development.

Well is located approximately 100 feet west of Antelope Creek with a difference in elevation of plus 15 feet.

12. Construction work will be completed on or before October 1, 1980.

13. The water will be completely applied to the proposed use on or before October 1, 1981.

14. If the ground water supply is supplemental to an existing supply, identify the supply and existing water right. This filing will supplement 4.0 acres of Permit No. 10768; (T-2664).

Permit to Appropriate the Public Waters of the State of Oregon

This is to certify that I have examined the foregoing application and do hereby grant the same, **SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD** and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.20 cubic feet per second measured at the point of diversion from the well or source of appropriation, or its equivalent in case of rotation with other water users, from a well.

The use to which this water is to be applied is irrigation and supplemental irrigation.

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others,


and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.
The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.
The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.
The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

The priority date of this permit is March 2, 1978

Actual construction work shall begin on or before April 11, 1979 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1979

Complete application of the water to the proposed use shall be made on or before October 1, 1980
