THIS WELL HAS A 200 H.P. TURBINE PUMP AND PROVIDES WATER TO TWO 1/4 MILE CIRCULAR PIVOT SYSTEMS. MAINLINE RUNS DUE EAST FROM WELL WITH PORTABLE LINE USED FOR CORNERS

Remarks: THIS WELL WAS DRILLED ABOUT 1953. FOR YEARS IT WAS USED ONLY TO WATER SHEEP. AT ONE TIME, AN ATTEMPT WAS MADE TO FLOOD IRRIGATE IN SEC. 22. PRESENT IRRIGATION SYSTEM WAS ESTABLISHED APPROXIMATELY EIGHT YEARS A.G.O. THROUGH THE OVERSIGHT AND MISCONCEPTION OF A SUCCESSION OF OWNERS, NO APPLICATION WAS MADE TO IRRIGATE THE LAND DESIGNATED ON THIS APPLICATION. THIS WELL IS ESTIMATED TO BE 6 TO 7' DEEP - "ROCK MOST OF THE WAY," AND COULD PRODUCE AN ESTIMATED 4800 G.P.M.

Permit to Appropriate the Public Waters of the State of Oregon

G 8888

This is to certify that I have examined the foregoing application and do hereby grant the same, **SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD** and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 3.5 cubic feet per second measured at the point of diversion from the well or source of appropriation, or its equivalent in case of rotation with other water users, from one well

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.


The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

The priority date of this permit is July 10, 1980

Actual construction work shall begin on or before August 7, 1981 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1981

Complete application of the water to the proposed use shall be made on or before October 1, 1982
