make application for a permit to appropriate the following described ground waters of the State of Oregon:

1. The development will consist of one well (Give number of wells, tile lines, infiltration galleries, etc.)

having a diameter of 10 inches and an estimated depth of 315 feet.

2. The well or other source is to be located 390 ft. North and 490 ft. West (N. or S.) (E. or W.)

from the Northwest corner of Lot 2 (also Northwest corner of R. Hurley (Public Land Survey Corner)

Donation Land Claim) (If there is more than one well, each must be described)

being within the Northwest 1/4 of the Southeast 1/4 of

Sec. 1 Tp. 5 South R. 2 West, W. M., in the county of Marion

3. Location of area to be irrigated, or place of use if use other than irrigation.

4. It is estimated that 277 feet of the well will require 250 gage casing. (Kind)

5. Depth to water table is estimated 34 Well drilled by S & M Drilling & Supply, Inc. (Feet)

6. The amount of water which the applicant intends to apply to beneficial use is 1.3392856 cubic feet per second or 600 gallons per minute.

7. The use to which the water is to be applied is irrigate row crops, berries and pasture.

8. If the flow to be utilized is artesian, the works to be used for the control and conservation of the supply when not in use must be described.

9. If the location of the well, or other development work is less than one-fourth mile from a natural stream channel, give the distance to the channel and the difference in elevation between the stream bed and the ground surface at the source of development.

About 1/4 mile West and 30 feet below the ground surface level of the well is Senecal Creek.

10. **DESCRIPTION OF WORKS**

Include length and dimensions of supply ditch or pipeline, size and type of pump and motor, type of irrigation system to adequately describe the proposed distribution system.

There is a 30-horse power motor that drives a turbine pump. The column is extended 102 feet into the well below the discharge on the pump at ground level. From that discharge point at ground level, the irrigation water goes back into a 6-inch underground mainline that goes East about 15 feet and then divides, with one line going North about 30 feet to a riser and a second line going South about 30 feet, then West about 150 feet, then South about 325 feet to a second riser, and then continuing South about 30 feet under an access road and then West about 100 feet to a final and third riser.

11. Construction work will begin on or before completed

12. Construction work will be completed on or before completed

13. The water will be completely applied to the proposed use on or before October 1, 1983

14. If the ground water supply is supplemental to an existing supply, identify the supply and existing water right. N.A.

Permit to Appropriate the Public Waters of the State of Oregon

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.65 cubic feet per second measured at the point of diversion from the well or source of appropriation, or its equivalent in case of rotation with other water users, from a well

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.

The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

The priority date of this permit is January 26, 1981

Actual construction work shall begin on or before March 24, 1982 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1982

Complete application of the water to the proposed use shall be made on or before October 1, 1983
