PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined Application G-9570 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Oregon Propagating Company of 15696 Highway 101 South, Brookings, Oregon 97415, Phone 469-3136, for the use of the waters of one well, for the purpose of supplemental irrigation and temperature control, being 1.07 cubic feet per second for supplemental irrigation and 2.5 cfs for temperature control; that the priority of the right dates from February 25, 1980 and is limited to the amount of water which can be applied to beneficial use and shall not exceed 2.5 cubic feet per second measured at the point of diversion from the well, or its equivalent in case of rotation with other water users.

The well is to be located: 650 feet north and 2,415 feet west from the southeast corner of Section 9, being within the SW 1/4SE 1/4, Township 41 South, Range 13 West, WM, in the county of Curry.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed two and one-half acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.

The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before February 8, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October -1, 1983.

Complete application of the water to the proposed use shall be made on or before October 1, 2000 1984. 26 July 23
