## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-9252 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Alfred Meisner of Cascadian Nurseries, 13495 NW Thompson Road, Portland, Oregon 97229, phone 645-3351, for the use of the waters of a well, for the PMRPOSE of supplemental irrigation, container nursery use and greenhouse nursery use, being 0.18 cubic foot of water per second for supplemental irrigation, 0.17 cfs for container nursery use and 0.06 cfs for greenhouse nursery use; that the PRIORITY OF THE RIGHT dates from May 23, 1979, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.41 cfs measured at the point of diversion from the well, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: North 30 degrees 5 minutes West, 361.25 feet from the \$1/4 Corner of Section 21, being within SE 1/4 SW 1/4 of Section 21, Township 1 North, Range 1 West, WM, in the County of Washington.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township I North Range I West, WM Section 21 SE 1/4 SW 1/4

14.0 acres irrigation, containerized nursery use and greenhouse nursery use

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed two and one-half acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall be further limited to a diversion of not to exceed 1.0 acre-foot per acre irrigated during the period from October 1 to March 31, provided further that the right allowed herein, together with the amount secured under any other right existing for the same land, shall not exceed two and one-half acre-feet for each acre irrigated in any one year and shall conform to such reasonable rotation system as may be ordered by the proper state officer. The use allowed herein for supplemental irrigation may be made at any time between October 1 and March 31 so that water can be put to beneficial use by irrigation, either for immediate crop growth or for forecast requirements, to raise the soil moisture to field capacity in the soil profile to be utilized by plant growth in the subsequent growing season.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.

The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.
