PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-9789 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Luckiamute Domestic Water Cooperative, by Allen Horton, Manager, of 8585 Suver Road, Monmouth, Gregon 97361, phone 838-2075, for the use of the waters of three wells, for the PURPOSE of group domestic uses for 50 families; that the PRIORITY OF THE RIGHT dates from January 6, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.05 cubic foot per second measured at the point of diversion from the well, or its equivalent in case of rotation with other water users.

The wells are to be LOCATED: Well I - 62.3 feet South and 3,346.9 feet East from the Southwest Corner of DLC 40, being within the NE 1/4 NW 1/4 of Section 10, Township 9 South, Range 4 West, WM; Well 2 - 2,137.3 feet South and 3,421.9 feet East from the Southwest Corner of DLC 40, being within the NE 1/4 NW 1/4 of Section 10, Township 9 South, Range 4 West, WM; Well 3 - 2,911.28 feet North and 145.0 feet West from the Southeast Corner of DLC 42, being within the NW 1/4 SE 1/4 of Section 10, Township 9 South, Range 4 West, WM, in the County of Polk.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 8 South Range 5 West, WM Section 21 S 1/2 Group Domestic Section 22 All Section 23 All Section 25 W 1/2 Section 26 All

The wells shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.

The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before March 30, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983. Extended to October 1987

Complete application of the water to the proposed use shall be made on or before October 1, 1992 1984. Extended to October 1987 Extended to October 1, 1992
