PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-9374 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Larry R. and Janyce A. Andre of 38203 SE Porter, Estacada, Oregon 97023, phone 630-4287, for the use of the waters of two wells, being 0.14 cubic foot per second of water from Well 1 with any deficiency to be supplied by Well 2, for the PURPOSE of irrigation; that the PRIORITY OF THE RIGHT dates from August 21, 1979, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.14 cfs measured at the point of diversion from the wells, or their equivalent in case of rotation with other water users.

The wells are to be LOCATED: Well 1 - 700 feet South and 39 degrees 30 minutes West from the Northwest Corner of Section 26; Well 2 - 635 feet South and 12 degrees 30 feet West from the Northwest Corner of NE 1/4 SE 1/4 of Section 26, both being within the NW 1/4 SE 1/4 of Section 26, Township 3 South, Range 4 East, WM, in the County of Clackamas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 3 South	Range 4 East, WM	Section 26	NW 1/4 SE 1/4	9.5 acres
			NE 1/4 SE 1/4	1.7 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The wells shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the wells at all times.

The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before April 19, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983.

Complete application of the water to the proposed use shall be made on or before October 1, 1984.
