PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-10249 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Snow-McElligott, a Partnership of PO Box 416, Ione, Oregon 97843, phone 422-7257, for the use of the waters of Well 3 with any deficiency to be supplied by Wells 1 and 2, for the PURPOSE of irrigation and supplemental irrigation; that the PRIORITY OF THE RIGHT dates from September 21, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.94 cubic feet per second measured at the point of diversion from the wells, or its equivalent in case of rotation with other water users.

The wells are to be LOCATED: Well 1 - 1,750 feet North and 620 feet East from the Southwest Corner of Section 1, being within the NW 1/4 SW 1/4 of Section 1; Well 2 - 120 feet North and 2,260 feet East from the Southwest Corner of Section 1, being within the SE 1/4 SW 1/4 of Section 1; Well 3 - 2,260 feet East and 502 feet South from the Northwest Corner of Section 12, being within the NE 1/4 NW 1/4 of Section 12, all being within Township 1 South, Range 23 East, WM, in the County of Morrow.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The wells shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the wells at all times.

The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.
