PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-10022 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Mary Folmsbee of Gateway Route, Box 460, Madras, Oregon 97741, phone 489-3237, for the use of the waters of a well, for the PURPOSE of supplemental irrigation; that the PRIORITY OF THE RIGHT dates from March 18, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.89 cubic foot per second measured at the point of diversion from the well, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 112 feet 4 inches North and 193 feet West from the Southeast Corner of the NE I/4 NW I/4 of Section 30, being within the NE I/4 NW I/4 of Section 30, Township 8 South, Range 16 East, WM, in the County of Wasco.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 8 South Range 16 East, WM Section 19 SE 1/4 SW 1/4 30.4 acres SW 1/4 SW 1/4 9.0 acres Section 30 NE 1/4 NW 1/4 39.6 acres NW 1/4 NW 1/4 39.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.

The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before May 4, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983.

Complete application of the water to the proposed use shall be made on or before October 1, 1984.
