## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-9748 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to International Paper Company, Western Forest Research Center of 34937 Tennessee Road, Lebanon, Oregon 97355, phone 259-2651, for the use of the waters of two wells manifolded together, for the PURPOSE of irrigation, temperature control, and greenhouse uses, being 0.57 cubic foot per second of water for irrigation, 0.45 cfs for temperature control, and 0.11 cfs for greenhouse use; that the PRIORITY OF THE RIGHT dates from July 28, 1981 for use of water for irrigation and temperature control and March 18, 1982 for use of water in greenhouse, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.68 cfs measured at the point of diversion from the wells, or their equivalent in case of rotation with other water users.

The wells are to be LOCATED: Well 1 - 756 feet South and 146 feet East; well 2 - 756 feet South and 266 feet East, both from the Northwest Corner of Section 23, being within the NW 1/4 NW 1/4 of Section 23, Township 11 South, Range 2 West, WM, in the County of Linn.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The wells shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the wells at all times.

The permittee shall install and maintain weirs, meters, or other suitable measuring devices, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before June 22, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983.

Complete application of the water to the proposed use shall be made on or before October 1, 1984.
