PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-10279 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to James Jackson of Route 2, Box 306, Bandon, Oregon 97411, phone 347-3294, for the use of the waters of two wells, being 0.86 cubic foot per second of water from Well 2 and 0.83 cfs from Well 3, for the PURPOSE of supplemental supply for irrigation, temperature control, and flood harvesting, being 0.14 cfs for irrigation, 0.86 cfs for temperature control, and 0.29 cfs for flood harvesting from Well 2, and 0.14 cfs for irrigation, 0.83 cfs for temperature control, and 0.28 cfs for flood harvesting from Well 3; that the PRIORITY OF THE RIGHT dates from April 23, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.69 cfs measured at the point of diversion from the wells, or their equivalent in case of rotation with other water users.

The wells are to be LOCATED: Well 2 - 500 feet North and 1,910 feet West from the E1/4 Corner of Section 28, being within the SW 1/4 NE 1/4 of Section 28; Well 3 - 1,540 feet North and 1,030 feet West from the E1/4 Corner of Section 28, being within the NE 1/4 NE 1/4 of Section 28, both being within Township 28 South, Range 14 West, WM, in the County of Cooks.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

If for irrigation, this appropriation shall be limited to 1/40 of one cubic foot per second of its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to 1/80 of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The permittee shall record and submit annually to the Water Resources Department all pertinent data pertaining to use of water for temperature control (frost protection) on forms furnished.

The wells shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the wells at all times.

The permittee shall install and maintain weirs, meters, or other suitable measuring devices, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before June 22, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983.

Complete application of the water to the proposed use shall be made on or before October 1, 1984.
