## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-9865 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to T.F.M. and G. Trust and the Goldnest Trust of Route 4, Box 1200, Hillsboro, Oregon 97123, phone 628-1118, for the use of the waters of three wells, being 425 gallons per minute from Well 1, 900 gpm from Well 2, and 100 gpm from Well 3, for the PURPOSE of nursery and related uses and containerized nursery stock use, being 1,425 gpm for nursery and related uses, and 1,425 gpm for containerized nursery stock use; that the PRIORITY OF THE RIGHT dates from June 11, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1,425 gpm measured at the point of diversion from the wells, or their equivalent in case of rotation with other water users.

The wells are to be LOCATED: Well 1 - 775 feet South and 850 feet East from the Northwest Corner of Section 8, being within the NW 1/4 NW 1/4 of Section 8; Well 2 - 1,200 feet South and 850 feet East from the Northwest Corner of Section 8, being within the NW 1/4 NW 1/4 of Section 8; Well 3 - 430 feet North and 960 feet East from the W 1/4 Corner of Section 8, being within the SW 1/4 NW 1/4 of Section 8, all within Township 2 South, Range 2 West, WM, in the County of Washington.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The wells shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the wells at all times.

The permittee shall install and maintain weirs, meters, or other suitable measuring devices, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before June 28, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983.

Complete application of the water to the proposed use shall be made on or before October 1, 1984.
