PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-10616 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Richard A. Fowler of Route 1, Box 477, Pendleton, Oregon 97801, phone 276-6171, for the use of the waters of one well, for the PURPOSE of irrigation and supplemental irrigation; that the PRIORITY OF THE RIGHT dates from December 24, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.42 cubic feet per second measured at the point of diversion from the well, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 70 feet North and 350 feet East from the S 1/4 Corner of Section 17, being within the SW 1/4 SE 1/4 of Section 17, Township 2 North, Range 34 East, WM, in the County of Umatilla.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of perfection of this right, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.

The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before July 2, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983. Extended to Oct. 1, 1984

Complete application of the water to the proposed use shall be made on or before October 1, 1984.
