PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-10637 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Dan Carl Rajnus of Star Route, Box 80-A, Malin, Oregon 97632, phone 723-4594, for the use of the waters of Wells 1, 2 and 5, being 0.47 cubic foot of water per second from Well 1, 0.40 cfs from Well 2 and 1.56 cfs from Well 5, for the PURPOSE of irrigation; that the PRIORITY OF THE RIGHT dates from January 27, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 2.43 cfs measured at the point of diversion from the wells, or its equivalent in case of rotation with other water users.

The wells are to be LOCATED: Well I - 1,435 feet South and 130 feet West from the N 1/4 Corner of Section 13, being within the SE 1/4 NW 1/4 of Section 13; Well 2 - 2,540 feet South and 1,800 feet West from the N 1/4 Corner of Section 13, being within the SW 1/4 NW 1/4 of Section 13; and Well 5 - 620 feet South and 1,200 feet West from the Northeast Corner of Section 25, being within the NE 1/4 NE 1/4 of Section 25, ell within Township 40 South, Range 11 East, WM, in the County of Klamath.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of these wells, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of these wells at the time of perfection of this right, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The wells shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the wells at all times.

The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before July 20, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983.

Complete application of the water to the proposed use shall be made on or before October 1, 1984.
