## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-10717 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Bruce W. Molesworth of Route 1, Box 27, Mosier, Oregon 97040, phone 478-3442, for the use of the waters of two wells, being 0.03 cubic feet per second from Well 1 and 0.29 cfs from Well 2.  
for the PURPOSE of irrigation

that the PRIORITY OF THE RIGHT dates from May 17, 1982

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.32 cubic foot per second

measured at the point of diversion from the wells, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Well 1 - 470 feet South and 370 feet West from the N 1/4 Corner of Section 18, being within the NE 1/4 NW 1/4 of Section 18; Well 2 - 1,050 feet South and 1,490 feet West from the N 1/4 Corner of Section 18, being within the NW 1/4 NW 1/4, Section 18, Township 2 North, Range 12 East, WM; in the County of Wasco.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 2 North, Range 12 East, WM	Section 18	NW 1/4 NW 1/4	2.5 acres from Well 1
		NW 1/4 NW 1/4	23.5 acres from Well 2

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of perfection of this right, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before July 20, 1983, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 83.

Complete application of the water to the proposed use shall be made on or before October 1, 19 84.
