PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-10661 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to McNulty Water Association of PO Box 177, St. Helens, Oregon 97051, for the use of the waters of Millard Road Well, for the PURPOSE of quasi-municipal use; that the PRIORITY OF THE RIGHT dates from February 23, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.0 cubic foot per second measured at the point of diversion from the well, or its equivalent in case of rotation ~~of~~ other water users.

The well is to be LOCATED: 1,255 feet North and 1,210 feet East from the Southwest Corner of Section 7, being within the SW 1/4 SW 1/4 of Section 7, Township 4 North, Range 1 West, WM, in the County of Columbia.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.

The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before August 16, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983.

Complete application of the water to the proposed use shall be made on or before October 1, 1984.
