## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-10741 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to City of Lincoln City, City Hall, PO Box 50, Lincoln City, Oregon 97367, phone 996-2151, for the use of the waters of a horizontal infiltration gallery, provided that the amount of water allowed herein together with the amount of water allowed under Permit 46867, shall not exceed a total of 6.0 cubic feet per second, for the PURPOSE of municipal use; that the PRIORITY OF THE RIGHT dates from June 8, 1982, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 6.0 cfs measured at the point of diversion from the well, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 200 feet North and 820 feet West from the E1/4 Corner of Section 25, being within the SE1/4 NE1/4 of Section 25, Township 7 South, Range 11 West, WM, in the County of Lincoln.

Shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times.

The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before August 20, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983. Extended to October 1, 1989, 10-1-2000

/0-1-95, 10-1-2000 Complete application of the water to the proposed use shall be made on or before October 1, 1984. Extended to October 1, 1990, 10-1-95, 10-1-2000
