PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-9714 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to City of Troutdale of 104 Kibling Street, Troutdale, Oregon 97060, phone 655-5175, for the use of the waters of two wells, being 2.2 cubic feet per second of water from Well 6, and 2.2 cfs from Well 7, for the PURPOSE of municipal; that the PRIORITY OF THE RIGHT dates from May 1, 1980 for 2.2 cfs and December 16, 1981 for 2.2 cfs, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 4.4 cfs measured at the point of diversion from the wells, or their equivalent in case of rotation with other water users.

The wells are to be LOCATED: Well 6 - 1,050 feet South and 1,950 feet West from the Northeast Corner of Section 1, being within the NE 1/4 NE 1/4 of Section 1, Township 1 South, Range 3 East, WM; Well 7 - 1,050 feet North and 1,220 feet West from the Southeast Corner of Section 36, being within the SE 1/4 SE 1/4 of Section 36, Township 1 North, Range 3 East, WM, both in the County of Multnomah.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The wells shall be constructed in accordance with the General standards for the Construction and Maintenance of Water Wells in Oregon.

The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the wells at all times.

The permittee shall install and maintain weirs, meters, or other suitable measuring devices, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before October 20, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984. **Extended to October 1, 1989,**

Complete application of the water to the proposed use shall be made on or before October 1, 1985. **Extended to October 1, 1989,** *10-1-95, 10-1-2000*
