PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-10651 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Gilbert L. and Anna C. Boyer of Route 1, Box 113, Adams, Oregon 97810, phone 226-7067 for the use of the waters of one well

for the PURPOSE of irrigation

that the PRIORITY OF THE RIGHT dates from February 17, 1982

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.20 cubic foot per second

measured at the point of diversion from the well, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 2,400 feet South and 50 feet West from the Northeast Corner of Section 6, being within the SE 1/4 NE 1/4 of Section 6, Township 3 North, Range 34 East, WM, in the County of Umatilla.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 3 North, Range 34 East, WM Section 6 SE 1/4 NE 1/4 16.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to $\frac{1}{80}$ of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before October 20, 1983, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
