## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-10718 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Hollis Cunter of 376 Bonnie Lane, Grants Pass, Oregon 97526, phone 479-8646 for the use of the waters of a well

for the PURPOSE of irrigation and supplemental irrigation

that the PRIORITY OF THE RIGHT dates from 10/ay 17, 1982

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 55.0 gallons per

measured at the point of diversion from the well , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 840 feet South and 290 feet East from the center of Section 30, being within the NW 1/4 SE 1/4 of Section 30, Township 35 South, Range 5 West, WM, in the County of Josephine.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 35 South, Range 5 West, WM Section 30 NW 1/4 SE 1/4 7.2 acres primary Section 30 NW 1/4 SE 1/4 2.8 acres supplemental

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before October 28, 1983 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 84.

Complete application of the water to the proposed use shall be made on or before October 1, 19  $\,85\,$  .
