PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-10045 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Jerry L. Haguewood of Route 1, Box 510, Pendleton, Oregon 97801, business phone 276-7633, residence 276-5966, for use of the waters of a well

for the PURPOSE of irrigation

that the PRIORITY OF THE RIGHT dates from December 10, 1980

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.56 cubic foot per second

measured at the point of diversion from the well , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 1,300 feet North and 500 feet West from the Southeast Corner of Section 11, being within the SE 1/4 SE 1/4 of Section 11, Township 2 North, Range 33 East, WM, in the County of Umatilla.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 2 North, Range 33 East, WM Section II SE 1/4 SE 1/4 35.6 acres NE 1/4 SE 1/4 9.1 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shell be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer. This appropriation of ground water is subject to the limitations and conditions stated in certain letters from the Technical Advisory Committee of the Confederated Tribes of the Umatilla Indian Reservation to the permittee, dated December 3, 1981 and August 26, 1982, copies of which are on file in the records of the Water Resources Department.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before December 7, 1983 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 84.

Complete application of the water to the proposed use shall be made on or before October 1, 19 85.
