PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-10421 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Avion Water Co., Inc., of 60813 Parrell Road, Bend, Oregon 97701, phone 382-5342, for use of the waters of 5 wells, being 150 gallons per minute from Well 1, 150 gpm from Well 2, 325 gpm from Well 3, 180 gpm from Well 4 and 325 gpm from Well 5 for the PURPOSE of quasi-municipal use

that the PRIORITY OF THE RIGHT dates from July 2, 1981

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1,130 apm

measured at the point of diversion from the wells , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Well 1 - 70 feet North and 2,242 feet West from Southeast Corner, Section 7, being within the SW 1/4 SE 1/4, Section 7; Well 2 - 240 feet South and 260 feet East from Center Corner, Section 18, being within the NW 1/4 SE 1/4, Section 18; Well 3 - 1,019 feet North and 640 feet West from the Southeast Corner of Section 18, being within the SE 1/4* A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* SE 1/4, Section 18; Well 4 - 195 feet South and 260 feet East from Center Corner, Section 18, being within the NW 1/4 SE 1/4, Section 18; Well 5 - 1,380 feet South and 1,500 feet West from Northeast Corner, Section 19, being within the SW 1/4 NE 1/4, Section 19, all in Township 18 South, Range 12 East, WM, County of Deschutes.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before February 11, 1984, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984. Extended to October 1, 1989, extended to 10-1-94, 10-1-99
