This is to certify that I have examined APPLICATION G-10762 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to City of Milwaukie, Oregon, of 10722 Southeast Main Street (City Hall), Milwaukie, Oregon 97222, phone 659-5171, for use of the waters of Well 7

for the PURPOSE of municipal

that the PRIORITY OF THE RIGHT dates from June 28, 1982

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 2.67 cubic feet per second

measured at the point of diversion from the well , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 456 feet South and 1,108.1 feet West from the Northwest Corner of the Garrett DLC 38, being within the NE 1/4 NE 1/4, Section 36, Township 1 South, Range 1 East, WM; in the County of Clackamas.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before February 11, 1984 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 84.

Complete application of the water to the proposed use shall be made on or before October 1, 19 85 .
