PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **G-10347** and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to **Avion Water Co., Inc., 60813 Farrell Road, Bend, Oregon 97702, phone 382-5342** for use of the waters of 2 wells, being 0.12 cubic foot per second per well

for the PURPOSE of **domestic supplies for 78 families including irrigation of lawns and gardens not to exceed one-half acre in area per family (Codyville)**

that the PRIORITY OF THE RIGHT dates from **January 13, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.24 cfs**

measured at the point of diversion from the **wells**, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: **Well 1 - 270 feet North and 445 feet East from Southwest Corner of Section 33, being within the SW 1/4 SW 1/4 of Section 33; Well 2 - 385 feet North and 1,300 feet East from the W 1/4 Corner of Section 33, being within the SW 1/4 NW 1/4 of Section 33, both in Township 17 South, Range 13 East, WM, in the County of Deschutes.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before **March 18, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 1984**.

Complete application of the water to the proposed use shall be made on or before **October 1, 1985**.
