## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-10599 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Avion Water Co. Inc., 60813 Parrell Road, Bend, Oregon 97702, phone 382-5342 for use of the waters of 1 well

for the PURPOSE of group domestic use for 53 families including irrigation of lawns and gardens not to exceed one-half acre in area per family (Gosney)

that the PRIORITY OF THE RIGHT dates from November 19, 1981

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.18 cubic foot per second

measured at the point of diversion from the well , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 868 feet South and 368 feet East from the  $N\,1/4$  Corner of Section 20, being within the  $N\,W\,1/4$  NE 1/4 of Section 20, Township 18 South, Range 13 East, WM, in the County of Deschutes.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 18 South, Range 13 East, WM Section 16 W 1/2 SW 1/4 SW 1/4 NW 1/4 Section 17 S 1/2 SW 1/4 S1/2 SE 1/4 Section 20 N 1/2 NW 1/4 N 1/2 NE 1/4

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before March 18, 1984 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984 • Extended to October 1, 1989, Extended to October 1, 1992, 100-1-97

Complete application of the water to the proposed use shall be made on or before October 1, 1985

Extended to October 1, 1992, 10-1-97
