PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-10783 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to **Forest Industries Insurance Mgmt. - Cornucopia Mine, of 3111 Southeast Santiam Highway, Albany, Oregon 97321, phone 928-2344, for use of the waters of 1 well (mine tunnel)**

for the PURPOSE of **for extraction and processing of minerals**

that the PRIORITY OF THE RIGHT dates from **July 21, 1982**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **1.5 cubic feet per second**

measured at the point of diversion from the **well**, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: **1,750 feet North and 40 feet West from S 1/4 Corner of Section 27, being within the NE 1/4 SW 1/4 of Section 27, Township 6 South, Range 45 East, WM, in the County of Baker.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 6 South, Range 45 East, WM Section 27 SW 1/4 SE 1/4 industrial-mineral extraction and processing

This permit is issued subject to the maintenance and use of adequate treatment facilities to remove the sediment before returning the water to any stream.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before **March 18, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 1984**. Extended to **October 1, 1988**

Complete application of the water to the proposed use shall be made on or before **October 1, 1985**. Extended to **October 1, 1988**
