PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

R-68182 and do hereby grant the same SUBJECT TO EXISTING RIGHTS This is to certify that I have examined APPLICATION AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to United States, Winema National Forest of PO Box 1390, Klamath 97601, phone 883-6714, for the construction of two Falls, Oregon reservoirs and storage of water from an unnamed stream, a tributary of Sprague River for livestock water, and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined* The dam will be LOCATED in the: Dam 1 - SW 1/4 NE 1/4 of Section 8; Dam 2 - NE 1/4 NW 1/4 of Section 17, both in Township 34 South, Range 9 East, WM, in the County of Klamath.

The maximum height will be feet above the stream bed or ground surface at the centerline. The top width will be *** , slope of upstream face 4:1 , slope of downstream face 4:1 , and height of dam above water line when full 2.0 feet

The area submerged by the reservoir, when full, will be

- by the Water Resources Director to be necessary to satisfy prior downstream rights.
- Dam 1 7.0; Dam 2 6.0
- Dam 1 30.0; Dam 2 6.0
- **** Dam 1 0.15 acre; Dam 2 0.16 acre ***** Dam 1 4.0 feet; Dam 2 5.0 feet

The location and dimensions of the spillway are: Around the dam, the bottom width of the spillway will be 5.0 feet. The top width of the spillway will be 6.0 feet. The distance between the crest of the dam and the crest of the spillway will be 2.0 feet.

The location and dimension of the outlet conduit will be: None.

The structure is in the channel.

The dam will be earthfill construction.

The right hereunder shall be limited to the storage of 0.83 acre-foot, being 0.35 af in Reservoir 1 and 0.48 af in Reservoir 2

The PRIORITY DATE of this permit is September 13, 1984

December 7, 1985, and shall thereafter be prosecuted with reasonable Actual construction work shall begin on or before diligence and be completed on or before October 1, 19 86 .
