PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R-65581 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to United States, Winema National Forest of PO Box 1390, Klamath Falls, Oregon 97601, phone 883-6714, for the construction of John Smith Reservoir and storage of water from an unnamed stream, a tributary of Sprague River for livestock use, and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored *

The dam will be LOCATED in the: A - NE 1/4 SE 1/4 of Section 10; B - SE 1/4 SW 1/4 of Section 11, both within Township 35 South, Range 10 East, WM, in the County of Klamath.

The maximum height will be 6.0 feet above the stream bed or ground surface at the centerline. The top width will be **, slope of upstream face ***, slope of downstream face ****, and height of dam above water line when full *****

The area submerged by the reservoir, when full, will be ***** , and the maximum depth of water will be 6.0 feet

* water when determined by the Water Resources Director to be necessary to satisfy prior downstream rights.

** A - 10.0; B - 6.0

*** A - 4:1; B - 3:1

**** A - 3:1; B - 2:1

***** A - 4.0 feet; B - 2.0 feet

***** A - 0.37 acre; B - 0.18 acre

The locations and dimensions of the spillways are: The bottom width of the spillway will be A - 10.0 feet; B - 3.0 feet. The top width of the spillway will be A - 15.0 feet; B - 6.0 feet. The distance between the crest of the dam and the crest of the spillway will be A - 4.0 feet; B - 2.0 feet.

The locations and dimensions of the outlet conduits will be: None.

The dams are in channel.

The dams will be earthfill construction.

The right hereunder shall be limited to the storage of 1.3 acre-feet, being 0.9 af in John Smith Reservoir and 0.4 af in an unnamed reservoir

The PRIORITY DATE of this permit is August 19, 1983 .

Actual construction work shall begin on or before March 11, 1986 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1986 .
