Application for a Permit to Construct a Reservoir and to Store for Beneficial Use the Unappropriated Waters of the State of Oregon

I, Elgin F. Schamburg (Name of Applicant)

of Sherwood, Route 3, Box 30 (Mailing Address)

State of Oregon, do hereby make application for a permit to construct the following described reservoir and to store the unappropriated waters of the State of Oregon, subject to existing rights.

If the applicant is a corporation, give date and place of incorporation

1. The name of the proposed reservoir is 3 reservoirs

2. The name of the stream from which the reservoir is to be filled and the appropriation made is Rock Creek

tributary of Tualatin River

3. The amount of water to be stored is 3/4 a.f. for each res. acre feet

4. The use to be made of the impounded water is irrigation (Irrigation, power, domestic supply, etc.)

The length on top will be 150 feet; length on bottom 150 feet; width on top 8 feet; slope of front or water side 3:1; slope on back 2:1; height of dam above water line when full 2 feet.
