## PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R-66674 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to United States, Winema National Forest of PO Box 1390, Klamatn Falls, Oregon 97601, phone 883-6714, for the construction of Applegate Reservoir and Slabhouse Reservoir and storage of water from unnamed streams, tributaries of Hog Creek for livestock use, and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when  $\ast$  The dam will be LOCATED in the: A - SW 1/4 NE 1/4 of Section 18, Township 33 South, Range 9 East, WM; B - SE 1/4 NW 1/4 of Section 11, Township 33 South, Range 8 East, WM, both in the County of Klamath.

The maximum height will be 6.0 feet above the stream bed or ground surface at the centerline. The top width will , slope of upstream face 4:1 , slope of downstream face 4:1 , and height of dam above water line when full 1.0 foot

The locations and dimensions of the spillways are: The bottom width of the spillway will be A=3.0 feet; B=4.0 feet. The top width of the spillway will be 5.0 feet. The distance between the crest of the dam and the crest of the spillway will be 1.0 foot.

The locations and dimensions of the outlet conduits will be: None.

The dams are in channel.

The dams will be earthfill construction.

The right hereunder shall be limited to the storage of 0.21 acre-foot, being 0.15 af in Applegate Reservoir and 0.06 af in Slabhouse Reservoir The PRIORITY DATE of this permit is September 22, 1983

Actual construction work shall begin on or before March 11, 1986 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 86 .
