## PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R-66676 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to United States, Winema National Forest of PO Box 1390, Klamath Falls, Oregon 97601, phone 883-6714, for the construction of two unnamed reservoirs and storage of water from unnamed stream, a tributary of Lost Creek for livestock use, and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the The dam will be LOCATED in the: A - SE 1/4 SW 1/4 of Section 25; B - NE 1/4 SW 1/4 of Section 14, both in Township 35 South, Range 5 East, WM, both in the County of Klamath.

3.0 The maximum height will be feet above the stream bed or ground surface at the centerline. The top width will , slope of downstream face \*\*\*\* , slope of upstream face , and height of dam above water line when full 2.0 feet

The area submerged by the reservoir, when full, will be

, and the maximum depth of water will be 4.0 feet

The right hereunder shall be limited to the storage of 0.8 acre-foot, being 0.07 af in Reservoir 1 and 0.73 af in Reservoir 2

The PRIORITY DATE of this permit is September 22, 1983

Actual construction work shall begin on or before March 11, 1986 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 86 .
