PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R-66680 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to United States, Winema National Forest of PO Box 1390, Klamath Falls, Oregon 97601, phone 883-6714, for the construction of Lost Creek and Lower Lost Creek Reservoirs and storage of water from Lost Creek, a tributary of Klamath Marsh for livestock use and road watering to be appropriated under Application 66695, Permit 49222,

The dam will be LOCATED in the: A - SE 1/4 SE 1/4; B - SW 1/4 SE 1/4 both of Section 13, Township 28 South, Range 8 East, WM, both in the County of Klamath.

The maximum height will be * feet above the stream bed or ground surface at the centerline. The top width will be 15.0 , slope of upstream face 4:1 , slope of downstream face 4:1 , and height of dam above water line when full **

The area submerged by the reservoir, when full, will be *** , and the maximum depth of water will be A - 1.5 feet; B - 2.0 feet

* A - 3.0; B - 4.0

** A - 1.5 feet; B - 1.0 foot

*** A - 0.115 acre; B - 0.043 acre

The locations and dimensions of the spillways are: The bottom width of the spillway will be A - 1-12" CMP; B - 3.0 feet. The top width of the spillway will be 5.0 feet. The distance between the crest of the dam and the crest of the spillway will be A - 1.5 feet; B - 1.0 foot.

The locations and dimensions of the outlet conduits will be: None.

The dams are in channel.

The dams will be earthfill construction.

The right hereunder shall be limited to the storage of 0.1 acre-foot, being 0.07 af in Lost Creek Reservoir and 0.03 af in Lower Lost Creek Reservoir

The PRIORITY DATE of this permit is September 22, 1983

Actual construction work shall begin on or before March 11, 1986 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 86 .
