 $R\!-\!65625$ and do hereby grant the same SUBJECT TO EXISTING RIGHTS This is to certify that I have examined APPLICATION AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to United States, Malheur National Forest of John Day, Oregon 97845, phone 575-1731, for the construction of Grasshopper Flat Reservoir, Roadside Reservoir, Loop Road Reservoir, Hall Creek Reservoir, and Section 34 NW Reservoir, and storage of water from unnamed tributaries of Hall Creek for livestock use, and is subject to the installation and maintenance of an outlet pipe, or to provide *
The dam will be LOCATED in the: Grasshopper Flat - SE 1/4 NW 1/4 of Section 32, Township 18
South, Range 31 East, WM; Roadside Reservoir - SE 1/4 NW 1/4 of Section 5, the maximum height will be 8.5 feet above the stream bed or ground surface at the centerline. The top width will be 8.0 , slope of upstream face 3:1 , slope of downstream face 2:1 and height will good height.
