## PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION **R-65538** and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to **USDA, Forest Service, Umatilla National Forest of 2517 SW Hailey Avenue, Pendleton, Oregon 97801, phone 276-3811**, for the construction of Drift Fence Pond Reservoir and storage of water from an unnamed stream, a tributary of Randall Canyon for livestock, and is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when \*

The dam will be LOCATED in the: **NW 1/4 SW 1/4 of Section 4, in Township 6 South, Range 32 East, WM, in the County of Umatilla.**

The maximum height will be **8.0** feet above the stream bed or ground surface at the centerline. The top width will be **10.0** , slope of upstream face **3:1** , slope of downstream face **3:1** , and height of dam above water line when full **3.5** feet

The area submerged by the reservoir, when full, will be **0.159** acre , and the maximum depth of water will be **10.0** feet

\* determined by the Water Resources Director to be necessary to satisfy prior downstream rights.

The dimensions of the spillway are: The bottom width of the spillway will be **4.0** feet. The top width of the spillway will be **10.0** feet. The distance between the crest of the dam and the crest of the spillway will be **3.5** feet.

The location and dimension of the outlet conduit will be: **None.**

The dam is in the channel.

The dam will be earthfill construction.

The right hereunder shall be limited to the storage of **0.795** acre-feet

The PRIORITY DATE of this permit is **August 15, 1983** .

Actual construction work shall begin on or before **November 15, 1986** , and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 1987** .
