PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R-65555 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to USDA, Forest Service, Umatilla National Forest of 2517 SW Hailey Avenue, Pendleton, Oregon 97801, phone 276-3811, for the construction of Falls Road Pond, Dead Cow Pond and Thompson Falls Pond and storage of water from unnamed streams, tributaries of Thompson Creek for livestock, and is subject to the installation and maintenance of an outlet pipe, or to provide other means to *

The dam will be LOCATED in the Falls Road Pond - NW 1/4 SE 1/4 of Section 27; Dead Cow Pond - SW 1/4 SW 1/4 of Section 26; Thompson Falls Pond - NE 1/4 NW 1/4 of Section 26, all in Township 6 South, Range 29 East, WM, all in the County of Morrow.

The maximum height will be ** feet above the stream bed or ground surface at the centerline. The top width will be *** slope of upstream face **** slope of downstream face 3:1, and height of dam above water line when full Falls Road Pond-2.5 feet; Dead Cow Pond-3.5 foot; Thompson Falls Pond-2.0 ft

The area submerged by the reservoir, when full, will be ***** and the maximum depth of water will be *****
* evacuate the stored water when determined by the Water Resources Director to be necessary to satisfy prior downstream rights.

** Falls Road Pond - 4.0 feet; Dead Cow Pond - 5.0 feet; Thompson Falls Pond - 5.0 feet

*** Falls Road Pond - 10.0 feet; Dead Cow Pond - 10.0 feet; Thompson Falls Pond - 8.0 feet

**** Falls Road Pond - 3:1; Dead Cow Pond - 3:1; Thompson Falls Pond - 4:1

***** Falls Road Pond - 0.046 acre; Dead Cow Pond - 0.118 acre; Thompson Falls Pond - 0.028 acre

***** Falls Road Pond - 3.5 feet; Dead Cow Pond - 6.0 feet; Thompson Falls Pond - 3.0 feet.

The dimensions of the spillways are: The bottom width of the spillways will be: 4.0 feet. The top width of the spillways will be: Falls Road Pond - 11.0 feet; Dead Cow Pond - 12.0 feet; Thompson Falls Pond - 9.0 feet. The distance between the crests of the dams and the crests of the spillways will be: Falls Road Pond - 2.5 feet; Dead Cow Pond - 3.5 foot; Thompson Falls Pond - 2.0 feet.

The locations and dimensions of the outlet conduits will be: None.

The dams are in the channel.

The dams will be earthfill construction.

The right hereunder shall be limited to the storage of 0.375 acre-feet, being 0.064 af in Falls Road Pond, 0.278 af in Dead Cow Pond and 0.033 af in Thompson Falls Pond

The PRIORITY DATE of this permit is August 15, 1983 .

Actual construction work shall begin on or before November 15, 1986 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 87 .
