PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R-68671 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to Harry Harms (General Manager) of Hastings Bulb Growers, Inc., PO Box 2155, Harbor, Oregon, 97415, phone 469-3759, for the construction of two reservoirs and storage of water from an unnamed stream (AKA Cooley Creek) and McVay Creek, tributaries of the Pacific Ocean, to be appropriated under Application 68672, Permit 49876, for supplemental irrigation.

The dam will be LOCATED in the: NE 1/4 NE 1/4 Section 22, Township 41 South, Range 13 West, WM, in the County of Curry.

The maximum height will be N/A feet above the stream bed or ground surface at the centerline. The top width will be N/A, slope of upstream face N/A, slope of downstream face N/A, and height of dam above water line when full N/A

The area submerged by the reservoir, when full, will be Res. A- * , and the maximum depth of water will be *
Res. B- *

* Res. A- 1.136 acres, and the maximum depth of water will be 12.0 feet,
Res. B- 0.654 acres, and the maximum depth of water will be 9.25 feet.

The location and dimension of the outlet conduit will be: None.

The dams are out of the channel.

The dams will be off channel-dug out construction.

** AF from McVay Creek and 2.23 AF from unnamed stream in Res. B during the nonirrigation season or when excess water is otherwise available.

The right hereunder shall be limited to the storage of 12.7 acre-feet annually, being storage of 4.0 AF from McVay Creek and 4.72 AF from unnamed stream in Res. A and storage of 1.75**
The PRIORITY DATE of this permit is August 11, 1986 .

Actual construction work shall begin on or before January 30, 1988 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 88 .
