PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R=68679 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to Oregon Department of Fish and Wildlife, 506 SW Mill Street, Portland, Oregon, 97207, phone 229-5701, for the construction of eight reservoirs and storage of water from Coyote Creek when available with any deficiency in the available supply from Coyote Creek to be made up by appropriation from Long Tom River, tributaries of Willamette River, for wildlife attraction.

The dam will be LOCATED in the: NE 1/4 NW 1/4 Section 35, Township 17 South, Range 5 West, WM, in the County of Lane.

The maximum height will be 3.6 feet above the stream bed or ground surface at the centerline. The top width will be 12.0 feet , slope of upstream face 1:4 , slope of downstream face 1:4 , and height of dam above water line when full 4.0 feet

The area submerged by the reservoir, when full, will be 19.85 acresand the maximum depth of water will be 68.77 AF.

The dimensions of the spillway are: Water will be allowed to flow over the edge of the ditch across lowlands into Fern Ridge Reservoir as sheet flow.

The location and dimension of the outlet conduits will be: 3 - 42" diameter CMP, 106 feet long through base of dams with slide gates to control flows.

The dams are out of the channel.

The dams will be earthfill construction.

* 1.66 AF in Field 3 Reservoir; 1.62 AF in Field 4 Reservoir; 1.82 AF in Field 5 Reservoir; 1.75 AF in Field 6 Reservoir and 1.75 AF in Field 7 Reservoir, during the nonirrigation season or when excess water is otherwise available.

The right hereunder shall be limited to the storage of 68.77 acre-feet annually, being 55.0 AF in Main Ditch Reservoir; 2.88 AF in Field 1 Reservoir; 2.29 AF in Field 2 Reservoir; * The PRIORITY DATE of this permit is February 25, 1986

Actual construction work shall begin on or before January 30, 1988, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1988.
