## PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

This is to certify that I have examined APPLICATION R-69324 and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to Lincoln Horizons, Inc. of 11875 Orrs Corner Road, Dallas, Oregon 97338, phone 623-5089, for the construction of an unnamed reservoir and storage of water from Rickreall Creek to be maintained and appropriated under Application 69325, Permit 50184 for recreation (esthetics) and irrigation, being storage of 11.2 acre-feet for recreation and 10.0 acre-feet for irrigation. The \*  
The dam will be LOCATED in the: Pond - SW 1/4 NW 1/4 of Section 35, Township 7 South, Range 5 West, WM, in the County of Polk.

The maximum height will be N/A feet above the stream bed or ground surface at the centerline. The top width will be N/A, slope of upstream face N/A, slope of downstream face N/A, and height of dam above water line when full N/A

The area submerged by the reservoir, when full, will be 4.0 acres, and the maximum depth of water will be 6.0 feet.

The location and dimension of the outlet conduit will be: 8 inch diameter PVC pipe overflow to Rickreall Creek.

The dam is out of the channel.

Storage will be in a pond excavated below natural ground level.

\* right allowed herein shall be further subject to conditions as follows:

1. The structure shall be constructed, operated and maintained in accordance with the approved plans and specifications and with the design intent.
2. The structure shall be constructed under the supervision of a registered engineer licensed in Oregon. No water shall be stored until this department receives written certification from the engineer that construction has been completed in accordance with the approved plans and specifications, and written authorization for storage is received from this department.
3. Upon completion of the project an "as-built" topographic map and area capacity curve shall be submitted to this department and stamped by a engineer licensed to practice in Oregon.

The right hereunder shall be limited to the storage of 21.2 acre-feet annually during the nonirrigation season or when excess water is otherwise available.

The PRIORITY DATE of this permit is December 2, 1987.

Actual construction work shall begin on or before February 28, 1989, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89.
