PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

R-69414 This is to certify that I have examined APPLICATION and do hereby grant the same SUBJECT TO EXISTING RIGHTS AND THE FOLLOWING LIMITATIONS AND CONDITIONS:

This permit is issued to Donald L. Bult of P.O. Box 112, Mehama, Oregon 97384-0112, phone 859-2761, for the construction of Bult Reservoirs $\sharp 1$, $\sharp 2$, $\sharp 3$ and $\sharp 4$ and storage of water from an unnamed stream to be appropriated under Application 69415, Permit 50203 for fish culture,

The dam will be LOCATED in the: #1, #2 and #3: all in NW1/4 NE1/4 of Section 18; #4; SW1/4 SE1/4 of Section 7, all in Township 9 South, Range 2 East, W.M., in the County of Marion.

* The maximum height will be feet above the stream bed or ground surface at the centerline. The top width will , slope of upstream face 3:1 , slope of downstream face 2:1 , and height of dam above water ** be *** line when full

The area submerged by the reservoir, when full, will be

#1: 3.0 feet; #2: 3.0 feet; #3: 5.0 feet; #4: 6.0 feet

#1: 3.0 feet; #2: 18.0 feet; #3: 8.0 feet; #4: 8.0 feet

#1: 2.0 feet; #2: 3.0 feet; #3: 3.0 feet; #4: 3.0 feet

**** #1: 0.05 acre; #2: 0.08 acre; #3: 0.03 acre; #4: 0.14 acre

***** #1: 6.0 feet; #2: 8.0 feet; #3: 6.0 feet; #4: 8.0 feet

The locations and dimensions of the spillways are: None. Excess water will be spilled through outlet conduit.

The locations and dimensionss of the outlet conduits will be: #1: 2-10 inch culverts; #2: one 18 inch culvert; #3: 2-10 inch culverts; #4: 2-10 inch culverts; all culverts will be located through the dams.

The dam will be in the channel.

The dams will be earthfill construction.

+ being 0.3 af in #1; 0.6 af in #2; 0.2 af in #3 and 1.1 af in #4.

The right hereunder shall be limited to the storage of 2.2 acre-feet annually during the nonirrigation season or when excess water is otherwise available,+ The PRIORITY DATE of this permit is October 19, 1987

Actual construction work shall begin on or before March 30, 1989 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 89 .
