### *PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS*

is hereby issued a permit to construct two reservoirs, being MULE POND AND CAMP POND, and store waters from UNNAMED TRIBUTARIES OF NORTH FORK MALHEUR RIVER for LIVESTOCK.

The permit to store these waters is granted under Reservoir Application R-67468 with a date of priority of OCTOBER 11, 1983. The amount of water entitled to be stored each year under such right, for the purposes aforesaid, shall not exceed 0.4 ACRE-FOOT, BEING 0.2 AF IN EACH RESERVOIR.

The storage of water allowed herein is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the Water Resources Director to be necessary to satisfy prior downstream rights.

The dams will be located in the:

1 SW 1/4 NW 1/4, Section 25, T 15 S, R 35.5 E, WM;  
1700 FEET SOUTH & 200 FEET EAST FROM NW CORNER, SECTION 25.

The maximum height will be 8.50 feet above the stream bed or ground surface at the centerline. The top width will be 8.0 feet, slope of upstream face 3:1, slope of downstream face 2:1, and height of dam above water line when full 2.5 feet. The area submerged by the reservoir, when full, will be 0.06 acre and the maximum depth of water will be 6.0 feet.

2 SW 1/4 NW 1/4, Section 36, T 15 S, R 35.5 E, WM;  
2600 FEET SOUTH & 600 FEET EAST FROM NW CORNER, SECTION 36.

The maximum height will be 8.50 feet above the stream bed or ground surface at the centerline. The top width will be 8.0 feet, slope of upstream face 3:1, slope of downstream face 2:1, and height of dam above water line when full 2.5 feet. The area submerged by the reservoir, when full, will be 0.06 acre and the maximum depth of water will be 6.0 feet.
