PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS

is hereby issued a permit to construct two reservoirs, being WIND POND RESERVOIR and TRACTOR POND RESERVOIR and store waters from UNNAMED TRIBUTARIES OF SQUAW CREEK for LIVESTOCK.

The permit to store these waters is granted under Reservoir Application R-67478 with a date of priority of OCTOBER 11, 1983. The amount of water entitled to be stored each year under such right, for the purposes aforesaid, shall not exceed 0.04 ACRE-FOOT, BEING 0.02 AF IN EACH RESERVOIR.

The storage of water allowed herein is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate the stored water when determined by the Water Resources Director to be necessary to satisfy prior downstream rights.

The dams will be located in the:

1 NE 1/4 NE 1/4, Section 17, T 15 S, R 37 E, WM;
1000 FEET SOUTH & 1100 FEET WEST FROM NE CORNER, SECTION 17.

The maximum height will be 8.50 feet above the stream bed or ground surface at the centerline. The top width will be 8.0 feet, slope of upstream face 3:1, slope of downstream face 2:1, and height of dam above water line when full 2.5 feet. The area submerged by the reservoir, when full, will be 0.06 acre and the maximum depth of water will be 6.0 feet.

2 NW 1/4 SE 1/4, Section 17, T 15 S, R 37 E, WM;
1800 FEET NORTH & 2100 FEET WEST FROM SE CORNER, SECTION 17.

The maximum height will be 8.50 feet above the stream bed or ground surface at the centerline. The top width will be 8.0 feet, slope of upstream face 3:1, slope of downstream face 2:1, and height of dam above water line when full 2.5 feet. The area submerged by the reservoir, when full, will be 0.06 acre and the maximum depth of water will be 6.0 feet.
