### *PERMIT to CONSTRUCT a RESERVOIR and to STORE for BENEFICIAL USE the PUBLIC WATERS*

are hereby issued a permit to construct HOCKEMA RESERVOIR and store water from AN UNNAMED STREAM, A TRIBUTARY OF FALL CREEK FOR IRRIGATION AND STOCK WATERING, OF WHICH 2.55 ACRE-FEET WILL BE APPROPRIATED UNDER APPLICATION 69690, PERMIT 50435 for IRRIGATION.

The permit to store these waters is granted under Reservoir Application R-69689 with dates of priority of AUGUST 23, 1988 FOR STORAGE OF 2.85 ACRE-FEET AND SEPTEMBER 23, 1988 FOR STORAGE OF 0.03 ACRE-FOOT. The amount of water entitled to be stored each year under such right, for the purposes aforesaid, shall not exceed 2.88 ACRE-FEET, BEING 2.55 ACRE-FEET FOR IRRIGATION AND 0.33 ACRE-FOOT FOR STOCK WATERING.

This permit is subject to conditions as follow:

1. The structure shall be operated and maintained in accordance with the approved plans and specifications and with the design intent.
2. The embankment shall be kept clear of trees, brush and other debris.
3. The embankment shall be kept free of burrowing animals.
4. The dam shall be constructed under the supervision of a registered professional engineer.

The dam will be located in the:

SE 1/4 SW 1/4 Section 1 T 14 S R 9 W, WM;

The maximum height will be 14.00 feet above the stream bed or ground surface at the centerline. The top width will be 8.0 feet, slope of upstream face 3:1, slope of downstream face 2:1, and height of dam above water line when full 2.4 feet. The area submerged by the reservoir, when full, will be 0.75 acre and the maximum depth of water will be 10.0 feet.

The area submerged by the reservoir is located in:

This development was reviewed and considered by the Water Resources Commission on DECEMBER 9, 1988.

Actual construction work shall begin on or before January 9, 1990, and shall be completed on or before October 1, 1990.

This permit is for the beneficial use of water. By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan. It is possible that the land use you propose may not be allowed if it is not in keeping with the goals and the acknowledged plan. Your city or county planning agency can advise you about the land-use plan in your area.
