is hereby issued a permit to construct UNNAMED RESERVOIR 1 AND STORE WATERS FROM WEST UNNAMED STREAM AND UNNAMED RESERVOIR 2 AND STORE WATERS FROM EAST UNNAMED STREAM, TO BE APPROPRIATED UNDER APPLICATION 69547, PERMIT 50716, TRIBUTARIES OF CROOKED CREEK, for IRRIGATION, FLOOD HARVESTING AND TEMPERATURE CONTROL (TO INCLUDE FROST PROTECTION AND HEAT CONTROL), BEING STORAGE IN RESERVOIR 1 OF 1.5 ACRE-FEET FOR IRRIGATION, 0.6 ACRE-FEET FOR TEMPERATURE CONTROL, 0.9 ACRE-FEET FOR FLOOD HARVESTING, AND STORAGE IN RESERVOIR 2 OF 1.5 ACRE-FEET FOR IRRIGATION, AND 1.5 ACRE-FEET FOR FLOOD HARVESTING.

The permit to store these waters is granted under Reservoir Application R-69546 with a date of priority of MARCH 8, 1988. The amount of water entitled to be stored each year under such right, for the purposes aforesaid, shall not exceed 6.0 ACRE-FEET, BEING 3.0 AF IN EACH RESERVOIR.

The dams will be located in the:

1 NW 1/4 NW 1/4, Section 17, T 29 S, R 14 W, WM.

The maximum height will be 9.9 feet above the stream bed or ground surface at the centerline. The top width will be 20.0 feet, slope of upstream face 3:1, slope of downstream face 2:1, and height of dam above water line when full 2.5 feet. The area submerged by the reservoir, when full, will be 0.33 acre and the maximum depth of water will be 9.0 feet.

2 NE 1/4 NW 1/4, Section 17, T 29 S, R 14 W, WM.

The maximum height will be 9.9 feet above the stream bed or ground surface at the centerline. The top width will be 30.0 feet, slope of upstream face 3:1, slope of downstream face 2:1, and height of dam above water line when full 2.5 feet. The area submerged by the reservoir, when full, will be 0.38 acre and the maximum depth of water will be 8.0 feet.

The area submerged by the reservoirs is located in:

Diversion screening or fish passage facilities shall be designed, installed and operated to Oregon Department of Fish and Wildlife specificiations.

The storage of water allowed herein is subject to the installation and maintenance of an outlet pipe, or to provide other means to evacuate water when determined necessary by the Water Resources Director to satisfy prior downstream rights.

Actual construction work shall begin on or before August 24, 1990, and shall be completed on or before October 1, 1991. The reservoir shall be filled, and complete application of the stored water to the use shall be made on or before October 1, 1992.

This permit is for the beneficial use of water. By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan. It is possible that the land use you propose may not be allowed if it is not in keeping with the goals and the acknowledged plan. Your city or county planning agency can advise you about the land-use plan in your area.
